## Public Sector Fiscal Balance Report (GFS Basis): The First Half of the Fiscal Year 2016

Mr. Krisada Chinavicharana, Director-General of the Fiscal Policy Office and Ministry of Finance's Spokesman announced the public sector fiscal balance figures for the first half of the fiscal year 2016 (October 2015 – March 2016). Public sector fiscal balance was in deficit of 359,670 million Baht (or 2.6 percent of GDP), 46.4 percent higher than the same period last year. Public sector revenue was 3,067,594 million Baht, 8.5 percent (286,599 million Baht) lower than the same period last year, mainly due to a decrease in SOEs revenue, particularly decreases in revenue of PTT Public Company Limited, TOT Public Company Limited, and Thai Airways International Public Company Limited. On the other hand, Public sector expenditure was 3,427,264 million Baht, 4.8 percent (172,530 million Baht) lower than the same period last year because of decreases in expenditures in large SOEs (PTT, TOT and THAI). Moreover, consolidated public sector primary balance was in deficit of 274,893 million Baht (or 2.0 percent of GDP).
