General Government Fiscal Balance Report (GFS Basis)¹:

The First 9 Months of the Fiscal Year 2025 (October 2024 - June 2025)

In the first 9 months of fiscal year 2025 (October 2024 – June 2025), general government revenue was 2,872,580 million Baht, which was 4,877 million Baht (0.2 percent) higher than the same period of the last year. On the other hand, general government expenditure in the first 9 months of fiscal year 2025 was 3,270,219 million Baht, which was 186,238 million Baht (6.0 percent) higher than the same period of the last year. The main reason was the central government's disbursement, both in term of current expenditure and capital expenditure were higher than the same period of the last year. Therefore, general government balance was in deficit of 397,639 million Baht, which accounted for 2.1 percent of GDP. Meanwhile, the consolidated general government primary balance, which excludes interest payment to reflect the substantive performance and the direction of fiscal policy, was also in deficit of 157,569 million Baht, or 0.8 percent of GDP.
